**AVA/2019/0572: Removal of existing roof and fitting new and the capping and repointing of chimney stacks at Goya Hairstyles, 82 Bridge Street, Belper.**

Please find below my response to the consultation concerning the above application. These comments will be taken to the World Heritage Site Conservation and Planning Panel for verification later this month.

The site lies within the Derwent Valley Mills World Heritage Site (DVMWHS). The Derwent Valley Mills were inscribed on the World Heritage List by UNESCO in 2001. The Derwent Valley Mills Partnership, on behalf of HM Government, is pledged to conserve the unique and important cultural landscape of the Derwent Valley Mills World Heritage Site; to protect its outstanding universal value (OUV), to interpret and promote its assets; and to enhance its character, appearance and economic well-being in a sustainable manner.

The retrospective Statement of Outstanding Universal Value (SOUV) for the Derwent Valley Mills was adopted by the World Heritage Committee in 2010. The SOUV refers to the following UNESCO criteria, which the World Heritage Committee agreed were met at the time of inscription. They are:

- C(ii) That the site exhibits “an important interchange of human values, over a span of time or within a cultural area of the world, on developments in architecture or technology, monumental arts, town planning or landscape design”;
- C(iv) That the site is “an outstanding example of a type of building or architectural or technological ensemble or landscape, which illustrates a significant stage in human history”.

The SOUV records that these criteria were met for the following reasons:

- C(ii) The Derwent Valley saw the birth of the factory system, when new types of building were erected to house the new technology for spinning cotton developed by Richard Arkwright in the late 18<sup>th</sup> century.

C(iv) In the Derwent Valley for the first time there was large-scale industrial production in a hitherto rural landscape. The need to provide housing and other facilities for workers and managers resulted in the creation of the first modern industrial settlements.

A Management Plan for the World Heritage Site was created in 2002, and updated in 2014. It has as the first of its nine aims to: “protect, conserve and enhance the Outstanding Universal Value of the DVMWHS.” In accordance with this aim, and with reference to Section 12.1 of the Management Plan, I have consulted with Derbyshire County Council’s Conservation, Heritage and Design Service (which advises the World Heritage Site Partnership in planning matters), and have received the following advice:

This unlisted building is within the Belper and Milford Conservation Area, which has an Article 4 Direction in force. The proposed works seem to be justified given the condition of the roof covering and chimney stacks, with tangible evidence of their failure. Were it possible to re-use up to 50% of the existing Welsh slate, it would be preferable to re-cover the front slope with the authentic historic material. However, the proposed roof covering would be natural slate, albeit of a different, imported type. The addition of cappings to the chimney pots should ensure their retention, if at all possible, or comprise replacements of an appropriate type, as advised by the Borough’s Conservation Officer.

As the works are generally sympathetic to the property and the area, it is considered that the significance of the World Heritage Site, as defined by its Outstanding Universal Value, would not be harmed as a result of the proposed works.

I hope these comments can be considered when a decision is made concerning this development.
